ORDER

No. 06-VV: Whereas a disciplinary proceeding under Rule 15 of the O.C.S.(C&A) Rules, 1962 was initiated against Sri Manas Ranjan Pattaik, Ex-WEO, Rayagada Block, Gajapati vide the ST&SC Development Department Memorandum No.13706/SSD, dated 27.04.2011. And whereas the Disciplinary Authority considered it necessary to appoint an Inquiring Officer to inquire into the charges framed against Sri Manas Ranjan Pattaik, Ex-WEO, Rayagada Block, Gajapati and appointed the Sub-Collector, Parlakemundi as the Inquiring Officer and nominated the B.D.O., Rayagada Block as the Marshalling Officer under rule-4 & 5 of Rule-15 of OCS(CC&A) Rules of 1962 vide Office Order No. 34347, dated 31.12.2014.

And whereas the Inquiring Officer submitted his enquiry report vide his letter no.2536, dated 04.09.2018.

And whereas the 1st Show Cause Notice along with the enquiry report was issued to the Delinquent Officer vide this Department no.17314/SSD, dated 06.09.2018. He was also intimated through a notice published in two local dailies viz, "The Samaj" and "The Dharitri" (dtd. 08.09.2018) to receive a copy of the 1st Show Cause Notice within 7 days of publication of the said notice and submit his representation against the findings of the Inquiring Officer.

And whereas the Delinquent Officer has not responded to the above mentioned Notice and has not submitted his representation within the stipulated time.

And whereas the 2nd Show Cause Notice along with the proposed punishment was issued vide No.18006/SSD, dated 20.09.2018 calling upon him to submit his representation against the proposed punishment within 7 days of publication of the said notice. The same was also published in two local dailies viz, "The Samaj" and "The Dharitri" (dtd. 21.09.2018).

And whereas the Delinquent Officer has not submitted his representation against the proposed punishment within the stipulated time.

And whereas after careful consideration of article of charges, enquiry report of the Inquiring Officer, the Disciplinary Authority has been pleased to impose the following punishment on the Delinquent Officer on finalisation of the disciplinary proceeding.
