

S.O. 4132 (E) – Whereas by the notification of the Government of India in the Ministry of Road Transport and Highways published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (ii) issued under sub-section (1) of section 3A of the National Highways Act, 1956 (48 of 1956) (hereinafter referred to as the said Act), the Central Government declared its intention to acquire the land specified in the Schedule annexed to the said notification for building (widening / 4 laning, etc.), maintenance, management and operation of National Highway No.55 on the stretch of land from Km. 0 to Km 28 in District of CUTTACK in the State of ODISHA;

And whereas, the substance of the said notification has been published in "Prameya" and "Pragativadi" both dated 24th April, 2018, under sub-section (3) of section 3A of the said Act;

And whereas, objections have been received and the same have been considered and disallowed by the competent authority;

And whereas, in pursuance of the sub-section (1) of section 3D of the said Act, the competent authority has submitted its report to the Central Government;

Now, therefore, upon receipt of the said report of the competent authority and in exercise of the powers conferred by sub-section(1) of section 3D of the said Act, the Central Government hereby declares that the land specified in the said Schedule annexed hereto should be acquired for the aforesaid purpose;
