STARTING AN INDUSTRY

Initial approvals and clearances for establishing an industry



- Infowizard: Customised list of incentives & approvals



- Govt. of Odisha Portal for Land Use and Services (GO PLUS) GIS enabled Land Bank system



- State Level Facilitation Cell: One-stop facility to provide handholding support for industries



- Only 2 documents to be submitted for electricity connection
- Fixed cost estimate per KVA on contract demand
- Charged connection provided within 15 days



- Building plan approval in 30 days
- Master plans for Development Authorities available online
- NoCs for industrial buildings fast-tracked through joint site inspections
- Single Building code applicable across the State
- Third Party certification for architectural drawings and structural designs
- Reduction in processing duration for Tree Transit permission from 180 days to 42 days

PRE-COMMENCEMENT OF INDUSTRY

Approvals and clearances to enable the operations of the established industry



- All White category industries exempted from consent administration from State Pollution Control Board (SPCB)



- Consent to operate validity increased to 5 years
- Timelines reduced by 50%



- Online Property Registration
- Auto-calculation of fee and stamp duty

POST-COMMENCEMENT OF INDUSTRY

Renewal of approvals and Inspections after commencement of operations



Govt. of Odisha: Synchronised Mechanism for Inspection of Licensed Enterprise (GO SMILE)

- Risk-based selection of units and allocation of inspectors on a random basis using computerised online system.
- Inspection reports submitted within 48 hours
- Inclusion of Legal Metrology under Central Inspection Framework



- Incentive Administration: Online application, sanction letter and disbursement of incentives under the Industrial Policy 2015

- Post land allotment services through Automated Post Allotment Application (APAA)

• Voluntary Compliance Scheme: Enables self-compliance for labour laws

- Factory license for 10 years
- Third party certification of Boilers allowed
- Green category industries exempted from inspections
- Inspection frequency reduced to once every 6 months from earlier 3 months by SPCB
- Third party certification of internal electrical installations

- One-stop repository for all CSR related activities
- Dovetail CSR activities with developmental goals of the State
