

S.O. 1013 (E).- In exercise of powers conferred by sub-section (1) of section 3 (A) of the National Highways Act, 1956 (48 of 1956) (hereinafter referred to as the said Act), the Central Government, after being satisfied that for the public purpose, the land, the brief description of which is given in the Schedule below, is required for building (widening/Six laning etc.), maintenance, management and operation of N.H-16 (old NH-5) in the stretch of land from Km 62.000 to Km 136.500 (Chandikhole - Bhadrak Section) in the district of BHADRAK in the state of ODISHA, have declared its intention to acquire such land vide their Gazettee Notification No. S.O. 1013 (E) dt. 22nd February, 2019 published on dt. 23.02.2019 Extraordinary, Part-II.

Any person interested in the said land may, within twenty-one days from the date of publication of this notification in the Official Gazette, object to the use of such land for the aforesaid purpose under sub-section(1) of section 3C of the said Act.

Every such objection shall be made to the **Competent Authority-cum-Land Acquisition Officer (NH), Khordha at Bhubaneswar or Tahasil Office Bhandaripokhari, Dist-Bhadrak** in writing and shall set out the grounds thereof and the Competent Authority shall give the objector an opportunity of being heard, either in person or by a legal practitioner, and may, after hearing all such objections and after making such further enquiry, if any, as the Competent Authority thinks necessary, by order, either allow or disallow the objections.

Any order made by the Competent Authority under sub-section (2) of section 3C of the said Act shall be final.

The land plans and other details of the land to be acquired under their notification are available and can be inspected by the interested person at the aforesaid office of the Competent Authority during working hours.
