ORDER

Sub : Permission to carry out exploration over 2.9842 ha of forest land out of total Block area of 1129.236 ha (forest land 542.977 ha + 586.239 ha non-forest land) through drilling 58 nos. borehole at Keluamali Bauxite Block under Thuamul-Rampur Tahasil of Kalahandi District assigned by the State Government of Odisha to Odisha Mineral Exploration Corporation Limited (OMECL), Bhubaneswar as allotted by Government in Steel & Mines Department.

WHEREAS, General Manager (Exploration), Odisha Mineral Exploration Corporation Limited (OMECL), Bhubaneswar had applied for undertaking exploratory drilling of 58 no. of boreholes comprising of 32 no. of boreholes in forest land (1.2000ha) of 4" dia and 1.7842ha of forest land access path at Keluamali Bauxite Block assigned by the State Government of Odisha to Odisha Mineral Exploration Corporation Limited (OMECL), Bhubaneswar for prospecting of mineral as per the provision of Govt. of India, MoEF&CC guideline dt.24.12.2018.

And whereas, the Govt. of India, MoEF&CC, Eastern Regional Office, Bhubaneswar vide their letter No.5-ORB390/2019-BHU dtd.21.10.2019 in consideration of the relevant proposal of the State Government furnished vide letter No. 14453/F&E dttd.31.07.2019 have communicated their approval to carry out exploration over 2.9842 ha of forest land out of total Block area of 1129.236 ha (forest land 542.977 ha + 586.239 ha non-forest land) through drilling 58 nos. borehole at Keluamali Bauxite Block under Thuamul-Rampur Tahasil of Kalahandi District assigned by the State Government of Odisha to Odisha Mineral Exploration Corporation Limited (OMECL), Bhubaneswar as allotted by Government in Steel & Mines Department by the lessee as required under Notification dt.27.03.2018 and Rule 12 (4A) of MCDR, 2018 (*Annexure-I*).

Now therefore, Govt. of Odisha do hereby allow the lessee to carry out exploration over 2.9842 ha of forest land out of total Block area of 1129.236 ha (forest land 542.977 ha + 586.239 ha non-forest land) through drilling 58 nos. borehole at Keluamali Bauxite Block under Thuamul-Rampur Tahasil of Kalahandi District assigned by the State Government of Odisha to Odisha Mineral Exploration Corporation Limited (OMECL), Bhubaneswar as allotted by Government in Steel & Mines Department earlier received from PCCF, Odisha along with the proposal vide their letter No. 11923 dttd.06.07.2019. The statement showing the location of boreholes indicated and duly authenticated as earlier received from PCCF, Odisha vide their letter No.11923 dttd.06.07.2019 is appended herewith as *Annexure-II*.

The Collector, Kalahandi is authorized to allow for use of the forest land in question for the purpose of prospecting of minerals subject to having valid lease and compliance of Court's order if any, following due procedure of law. Before allowing the use of forest land to the user agency it shall be ensured that the Compensatory levies as due for this project is deposited, in full, at applicable rates.

The Divisional Forest Officer, Kalahandi (South) Division is also directed to monitor compliance to the conditions stipulated for such diversion in the respective forest clearance order and to report violations, if any, to the Nodal Officer, O/o the PCCF, Odisha and to the Forest & Environment Department.

Execution of project activities will be subject to having valid lease and availability of all other statutory clearances required under relevant Act/ Rules for this mining project, deposit of requisite funds and compliance of Court's order if any.

The user agency is asked to take following actions immediately as per orders of Hon'ble National Green Tribunal dt.07.11.2012 in Appeal No.7/2012 communicated by the MoEF, Govt, vide their letter F.No.7-23/2012-FC dttd.24.07.2013.

- (i) They shall publish the entire forest clearance granted in verbatim along with conditions and safeguards imposed by the Central Government in Stage-II forest clearance in two widely circulated daily newspapers, one in vernacular language and the other in English language so as to make people aware of the permission granted to the Project for use of forest land for non-forest purposes.
- (ii) They shall submit the copies of forest clearance orders granted by the Central Government/State Government to the Heads of local bodies and Municipal bodies along with the relevant offices of the State Government, who in turn, shall display the same for 30 days from date of receipt.
- (iii) Detailed action taken in compliance to the above order of State Government shall be intimated to the DFO, Kalahandi (South) Division / RCCF, Bhawanipatna/ PCCF, Odisha/ F&E Department for reference.

Besides the above, the applicant agency is also asked to deposit compensatory levies, as due for this project in full, at applicable rates. Also requisite funds due for deposit by the agency on account of this project shall also be deposited under appropriate head.

The applicant agency shall furnish compliances to the conditions prescribed in the 'forest/wildlife clearance order to the Divisional Forest Officer of Kalahandi (South) Division in every quarter, for the purpose of monitoring by him.

Sub:- Permission to carry out exploration over 2.9842 ha of forest land out of total Block area of 1129.236 ha (forest land 542.977 ha + 586.239 ha non-forest land) through drilling 58 nos. boreholes at Keluamali Bauxite Block under Thuamul-Rampur Tahasil of Kalahandi District assigned by the State Government of Odisha to Odisha Mineral Exploration Corporation Limited (OMECL), Bhubaneswar as allotted by Government in Steel & Mines Department.

Sir,

I am directed to refer to State Govt, letter No10F(Con)s/64/19-14453/F&E dated 31.07.2019 on the above mentioned subject seeking prior approval of the Ministry of Environment, Forest & Climate Change under section 2 of Forest (Conservation) Act, 1980.

2. After due consideration of the proposal of the State Government and on the basis of approval of Regional Empowered Committee meeting held on 03.10.2019, the Ministry of Environment, Forest & Climate Change **hereby conveys approval** to carry out exploration over 2.9842 ha of forest land out of total Block area of 1129.236 ha (forest land 542.977 ha + 586.239 ha non-forest land) through drilling 58 nos. boreholes at Keluamali Bauxite Block under Thuamul-Rampur Tahasil of Kalahandi District assigned by the State Government of Odisha to Odisha Mineral Exploration Corporation Limited (OMECL), Bhubaneswar as allotted by Government in Steel & Mines Department, subject to the fulfillment of the following conditions.

- (i) The user agency shall be allowed exploratory drilling of maximum of 32 no. of boreholes of 4" dia (32 boreholes @ 0.0375 ha each totaling 1.200 ha and 1.7842 ha for construction of road) for forest land.
- (ii) As per Ministry's letter No.5-3/2007-FC dated 24.12.2018, in case of proposal in forest areas with vegetation density between 0.1 and 0.4, then NPV is to be realized @ 2% or if with vegetation density 0.4 and 0.7, then NPV @ 5% for the total prospecting lease area in which exploration/prospecting/survey being proposed to be carried out shall be realized from the user agency.
- (iii) Any amount of NPV deposited in the stipulated Government account is non-refundable. However, the NPV deposited for prospecting in the area, will be adjusted against the estimated NPV to be levied, in case the approval is obtained for diversion of the same forest land for mineral extraction, under Section 2 of Forest (Conservation) Act, 1980.

(iv) The user agency shall prepare a plan to plant 20 tall trees per borehole area. The cost of preparation of plan and plantation shall be borne by the user agency. State Govt, shall ensure that the plants are planted on abandoned borehole area or degraded forest land, as per prescription of working plan.

(v) The prior approval of Govt, of India under Section 2 of FC Act for prospecting in this forest area under consideration is only for resource assessment and mapping and does not confer in any manner any right to the State Govt, to divert such forest land under Section 2 (ii) of Forest (Conservation) Act, 1980 for mining purpose in future in favour of this user agency or any other mining company on the plea that forest clearance for prospecting has been granted.

(vi) Charges towards NPV & CA as applicable shall be realized by the State Govt, from the user agency and deposited in Ad-hoc CAMPA fund through e-portal.

(vii) The user agency shall seek permission of concerned Divisional Forest Officer before entering into the forest area and borehole shall be dug with prior permission of the concerned Divisional Forest Officer and also furnish detailed report thereof on completion of the project.

(viii) Proper plugging of boreholes shall be made after exploration activities are completed to the satisfaction of the concerned Divisional Forest Officer.

(ix) No tree felling shall be undertaken for exploration activities as proposed by the State Govt. Project activities shall be restricted to clearing of bushes and lopping of tree branches if any for the purpose of site preparation.

(x) No labour camp shall be established and no other construction activities (temporary or permanent) shall be done by the user agency on forest land.

(xi) The user agency shall be responsible for any loss to the flora and fauna in the surrounding. Any damage done in this regard shall be compensated by the user agency from the project cost as assessment of the concerned Divisional Forest Officer.

(xii) No new road shall be constructed by the user agency for transporting prospecting tools and machines. The user agency may use the existing forest road/path with prior information to the concerned Divisional Forest Officer. The area use for path during the prospecting work shall be restored to its original status of forest after completion of prospecting work.

(xiii) No other construction activities shall be done by the user agency on forest land. Existing path and road only will be used by the user agency for the purpose of prospecting activities and drilling of borehole will be limited to 32 no. with diameter 4" with forest land will be dug.

(xiv) Any change in the diameter of borehole and number of boreholes will be reported to the concerned Regional Office in advance for consideration and recommendations to the Central Govt.

(xv) Adequate measures shall be taken by the user agency to ensure that prospecting activities do not harm the wildlife in the area. Any damage done in this context, shall be compensated by the user agency as per assessment, by the concerned Divisional Forest Officer.

(xvi) No labour camp shall be established on the forest land and no work shall be allowed after sunset.

(xvii) In case, right over forest land proposed to be used for prospecting purpose, has already been settled in favour of eligible claimants as per provisions of the Forest Right Act, 2006, the claimants shall either be compensated appropriately or location of borehole by suitably re-located.


(xviii) Initially the permission for prospecting will be granted for two years from the date of issue of this approval which can be extended for one more year with convincing justification from the State Govt, for extension.

(xix) In case of violations of conditions by the user agency, the permission for prospecting of minerals shall be suspended by the concerned Divisional Forest Officer. Further, it shall be enquired by the Nodal Officer (FCA) of the State Govt, and report to be submitted to the concerned Regional Office for appropriate action.

(xx) The samples collected during the prospecting shall be used purely for investigation purposes and shall in no case be used for trade or commerce purpose.

(xxi) To minimize disturbance to the wildlife, user agency shall take all possible measures to minimize noise during prospecting operations and halt the prospecting activities during night and during such periods in the day as may be advised by the concerned Chief Wildlife Warden, concerned State Forest Department.

(xxii) The user agency and the State Govt, shall ensure compliance to provisions of the MoEF&CC Guidelines


