S.O.1307(E). - Whereas by the notification of the Government of India in the Ministry of Road Transport and Highways number S.O.4668(E) dated 11th November 2021, published in the Gazette of India, Extraordinary, part II, Section 3, Sub-section (ii) issued under sub-section (1) of section 3A of the National Highway Act, 1956 (48 of 1956) (hereinafter referred to as the said Act), the Central Government declared its intention to acquire the land specified in the Schedule annexed to the said notification for building (widening/two lane with paved shoulder/four laneing etc.) Maintenance, management and operation of NH-57 in the stretch of land from Km. 294.2 to Km. 300.3 (Khordha Bypass) in the district of KHORDHA in the state of ODISHA.
