New Delhi, the 20th September, 2022

S.O. 4377(E).— Whereas by the notification of the Government of India in the Ministry of Road Transport and Highways, S.O. 4662(E) published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (ii) issued under sub-section (1) of section 3A of the National Highway Act, 1956 (48 of 1956) (hereinafter referred to as the said Act), the Central Government declared its intention to acquire the land specified in the Schedule annexed to the said notification for construction widening and strengthening to two lane with paved shoulders from km 296.500 to 336.500 (Mundamarai to Ratnapur Section) in the district of GANJAM in the state of ODISHA.
 And whereas the substance of the said notification has been published in "THE SAMAJ" and "THE DHARITRI" both dated 25.01.2022 and 26.01.2022; under sub-section (3) of section 3A of the said Act;
 And whereas No objections have been received with in the statutory period of the aforesaid notification.
 And whereas, in pursuance of sub-section (1) of section 3D of the said Act, the competent authority has submitted its report to the Central Government;
 Now, therefore, upon receipt of the said report of the competent authority and in exercise of the powers conferred by the sub-section (1) of section 3D of the said Act, the Central Government hereby declares that the land specified in the said Schedule should be acquired for the aforesaid purpose;
 And further, in pursuance of sub-section (2) of section 3D of the said Act, the Central Government hereby declares that on publication of this notification in the Official Gazette, the land specified in the said Schedule shall vest absolutely in the Central Government, free from all encumbrances.
